#### Children's Day Triathlon

On June 8<sup>th</sup>, International Children's Day, The National Institutes of Health (NIH) is sponsoring a Triathlon (swim/bike/run) in conjunction with YMCA for children ages 7 to 12 years-.

This event will include a 1.65-mile bicycle trek through Maplewood beginning at the YMCA and using Beech Ave, Linden Ave and Locust Avenues, Alta Vista Road and returning to the YMCA via Spruce Tree Ave. Money raised by the event will go to Special Love (a supportive charity for children with cancer), The Children's Inn (a home-away-from-home for children undergoing treatment at the NIH Clinical Center), Friends of the Clinical Center (a charity that seeks to reduce financial stress on families relating to medical treatment); and the YMCA of Metropolitan Washington.

#### Bethesda Downtown Plan: An update to the 1994 Bethesda Central Business District Plan

Last fall the Planning Board began a revision of the 1994 and 1976 Bethesda Central Business District (CBD) Sector Plan. What is it? As described in the 1994 plan: "An area master plan, after approval by the County Council and adoption by the Maryland National Capital Park and Planning Commission, constitutes an amendment to the General Plan of Montgomery County. As such, it provides a set of comprehensive recommendations and guidelines for use of publicly and privately owned land within its planning area. Each area plan reflects a vision of future development that responds to the unique character of the local community within the context of a County-wide perspective."

Since the kick-off meetings for the latest amendment began last fall, a number of public meetings have taken place to collect input from residents, developers, visitors and other interested parties on the future vision of the CBD. Maplewood residents and the MCA have been involved in these meetings. In addition, MCA has been involved in discussions with other neighborhood associations in the area to coordinate the views of residents. The schedule calls for a shift this spring from the collection of community views to analysis and the initial formulation of draft recommendations on select issues.

Are your vision and concerns with the development of downtown Bethesda represented? Come find out at the May meeting of the MCA when Planning Coordinator, Elza Hisel-McCoy, will describe the state of the plan and answer your questions.

What will downtown Bethesda look like in 2035? Would you like to see improved walkways or bikepaths – uptown, cross-town, or downtown? Perhaps, taller or shorter buildings and more or less office space or apartments? More or less nighttime entertainment and social activities? Better parking or improvements to traffic patterns? Places for people to gather outside? What are your ideas? Come to the next MCA meeting on May 28 and hear about the process to build a new downtown Bethesda plan that will cover the next 20 years and influence development (http://www.montgomeryplanning.org/community/bethesda\_downtown/index.shtm). Ezra Hitzel – McCoy, Plan Coordinator, will present the latest news and hear from Maplewood residents. Add your thoughts to the process! The draft plan will be sent to the Montgomery County Planning Board this fall.

#### **Pooks Hill Marriott Development Plans**

The proposal for several high-rise condominium buildings on the hotel's existing surface parking lot is once again moving forward. In the process of a Montgomery County- wide re-write of the Zoning Ordinance, the Planning Board staff has proposed zoning that would allow the Pooks Hill Marriott development project to proceed. Maplewood Citizens Association and The Promenade Condominiums on Pooks Hill Rd have histori-

cally opposed this proposed development project based on the traffic it would generate. MCA and The Promenade Condominiums have again joined forces with the goal of reducing the amount of development proposed.

A more detailed discussion of the issue and steps MCA will take in opposition will be presented at the May 28<sup>th</sup> membership meeting.

Because the final Council vote on the Zoning Ordinance is scheduled prior to the

Montgomery County primary election at the end of June 2014, a County Council candidates forum is being scheduled at The Promenade in the coming weeks. This forum will afford Maplewood residents the opportunity to speak to the incumbent candidates who are running for reelection. A large turnout for this event is encouraged. Details on the forum will be posted on the MCA list-serve when they are available.

### Maplewood Walking Group: Start Date - Thursday, May 29th

Join the newly forming Maplewood Walking Group!

A group of Maplewood residents has decided to inaugurate a walking group. The group will meet to walk every evening (7 days a week) at 7 pm at the sidewalk/driveway entrance to the Maplewood-Alta Vista Park at 5209 Alta Vista Road. The evening's route will be selected by the walkers who show up. Walk for as long and as far as you wish with a companionable group of your neighbors who are interested in exercise and in getting to know other Maplewood residents. Use of reflective clothing is STRONGLY encouraged.



#### Purple Line

The Purple Line is a proposed light rail line that will run from Bethesda to New Carrollton. The sixteen-mile line, with twenty-one stations, will connect the three METRO lines (Orange, Red, and Green) and the MARC stations at Silver Spring, Greenbelt, and New



Carrollton. The Purple Line is expected to relieve traffic congestion on east-west roads including the I-495 (Beltway), University Boulevard, East-West Highway, Montrose Road, and Randolph Road. It will be the only rapid transit line connecting Montgomery County and Prince George's County. In addition to relieving highway congestion, it will reduce the crowded Red Line by providing a direct route from Bethesda to Silver Spring that will take 10 minutes instead of the current half-hour now required from the Bethesda Metro Station.

The State of Maryland rated the Purple Line as its number one infrastructure project. Federal and state funds have been set aside to start construction in 2015. In the next few months, one of the six consortium groups bidding on the project will be chosen to design, build, and maintain the rail line for thirty-five years.
