A Different Way To Go Solar

A representative from **Neighborhood Sun Benefit Corporation** will be our guest speaker at the MCA general meeting, March 20, 2019. Neighborhood Sun is one source of community solar power for homeowners. Community solar power involves no solar panels on a house and is especially useful for homeowners who prefer to not invest in either the purchase or rent of solar panels on their house or for those homeowners whose access to the sun throughout the day is limited (trees, orientation, etc). Neighborhood Sun works with existing utility companies to provide solar power. Come to the meeting to learn more about this exciting new way to have solar power delivered to your home.

Pooks Hill Marriott Development Update

The Quadrangle Corporation plan to build two sixteen floor luxury rental apartment towers on property next to the Pooks Hill Marriott Hotel was approved by the Montgomery County Planning Board in the summer of 2018 subject to Quadrangle's submission of an Enhanced Transportation Agreement (ETA). Quadrangle has submitted its ETA and the Planning board staff has requested Quadrangle to make some minor changes to the ETA. Once those are received and approved construction will probably begin over the summer 2019.

The ETA provides for a shuttle from the two new buildings to the Medical Center Metro station and not to the originally proposed Grosvenor Metro. However, contrary to earlier statements by Quadrangle that neighbors might be able to use the shuttle, the ETA as submitted indicates that the shuttle will only be available to residents of Quadrangle's two buildings. The Planning Board staff is not requiring that the shuttle carry anyone other than the residents of the two buildings.

French International School Update

The French International School (FIS) continues to have discussions with the Maryland State Highway Administration (SHA) and the Planning Board staff on its proposal to establish a new elementary school on the property now occupied by FASEB along Rockville Pike (Route 355) and just south of Pooks Hill Rd.

SHA is concerned about traffic exiting the property and intending to go north on Rockville Pike. SHA contends that it would be too dangerous for drivers to cross three lanes of southbound Rockville Pike to reach the U-turn at Alta Vista Road. Consequently, SHA wants a separate exit into the neighborhood so that drivers can use the Alta Vista Rd light at Rockville Pike to go northbound. SHA is also concerned about potential traffic back-up and congestion at the property entrance and exit especially in the morning and evening rush hours due to the added in and out bound traffic.

Independently, the Planning Board staff is concerned about northbound vehicles on Rockville Pike trying to make U-turns at Pooks Hill Road in order to enter the property. The Planning Board staff believes that it will be difficult for cars, once they make the U-turn onto southbound Rockville Pike, to reach the current property entrance. Thus, the Planning Board wants one entrance to the school relocated further south and a new road

exiting the property directly into the Maplewood neighborhood. FIS is opposed to this proposal as it means a major redesign of the property layout to accommodate a new road.

MCA president Allen Myers, who has met with the Planning Board staff, will report on that discussion at the March 20 $^{\rm th}$ MCA general meeting.

Also, MCA has been informed that FIS is allowing TIC Camp to operate on its Forest Road campus over the summer. This camp, for children 7 – 16 years old, features both technology and sports activities. It is possible that operation of this camp may not comply with the Conditional Use Permit under which the FIS operates at the Forest Road campus and which was granted by Montgomery County. Allen Myers has prepared a draft of a letter to be sent on behalf of MCA to the Montgomery County Board of Appeals asking the Board of Appeals for its opinion in this regard. This letter will be presented at the March 20th MCA general meeting for discussion.

Should the Board of Appeals concur that FIS is required to seek a modification of its permit in order to host the camp and if FIS agrees to seek this modification, Maplewood residents would have the opportunity to learn more about the camp and to provide input on its use of the FIS site including hours of operation, noise and traffic, etc.

Wednesday pick up 4:00 pm to 8:00 pm. Membership CSA with \$500 paid in advance to the farm; use your credit towards the weekly deliveries between May 22- October 30, 2019. There are 24 planned delivery dates during the season which builds in 4 weeks of no delivery (great for vacations, etc.).

<u>DYNAMIC LANE SIGNALIZATION</u> Rt. 355/Rockville Pike and Jones Bridge Road



If you have comments (positive/negative) about the "dynamic lane" signalization at the intersection of south-bound (towards downtown Bethesda) Rockville Pike /Rt 355 at Jones Bridge Rd (JBR) please complete the customer service form at the following link and submit it to the Maryland State Highway Administration:

Once on the link, scroll down to select topic "Traffic/Pedestrian Signals" and select the sub-topic "Traffic Signal-Other".

During southbound Rt. 355 rush hours the two left lanes (2 green arrows) are permitted to turn left onto JBR eastbound. During non-rush hours only the inner most left lane is allowed to turn left onto JBR eastbound despite the 2 arrows (linked together) which blink red for both lanes. The white arrow supersedes the "fast lane" blinking red arrow by indicating that the "fast lane" traffic should proceed straight into Bethesda and is not permitted to turn left.

SHA has agreed to conduct a 60-day review of the "dynamic lane" signalization from a safety standpoint given what some drivers feel is a confusing situation. SHA welcomes your comments.
